We're so glad your child is enjoying participating in NewMoonGirls.com. All participation on NewMoonGirls.com is moderated by adults, and girls' contributions appear only with their first name or nickname, age, and state, province or country as in this example: Jamaya, 10, NJ. We never share personal details such as last names, cities, or specific location details.

There are some instances in which New Moon Girls share photographs that include their faces as part of their participation on New Moon. For example, a member might share a photo of herself participating in a form of activism or displaying a piece of artwork she has created, or she may share a video she created that contains her image and her voice. We believe this sharing, when done with parents' knowledge and approval, plays an important role at New Moon and in the sense of pride, reinforcement, and community that girls participate in when they are active here.

Photographs of faces and audio recording of voices are classified as personally identifiable information by the U.S. Children's Online Privacy Protection Act. If a girl wishes to share photos or videos containing her face or video or audio files with her face or voice, we seek your verifiable parental consent in the form of this signed permission form for the photo, video, or audio file to be stored in our database and shared at NewMoonGirls.com.

By signing this agreement, you give New Moon Girls permission to keep the file/s your child has shared in our database and to display it on NewMoonGirls.com. You understand that any content at NewMoonGirls.com may also be shared in marketing materials, social media, or PR channels from time to time.
